MONTE TITOLI S.p.A., with registered office in Milan, Piazza degli Affari No. 6, Tax Code No. 03638780159, belonging to the Euronext Group, Group VAT No. 10977060960 (hereinafter "**Monte Titoli**"), acting as of FAI SERVICE's "**Designated Representative**" (hereinafter the "**Company**" or "**FAI Service**"), pursuant to article 135-undecies of Legislative Decree 58/1998 ("TUF") and to art. 106, paragraph 4, of Decree Law no. 18 of 17 March 2020 ("D.L. Cura Italia") as amended and converted into Law no. 27 of 24 April 2020, as further extended by virtue of article 3 paragraph 14-sexies of Law n. 15 of 21 February 2025, of FAI SERVICE, in the person of its specifically tasked employee or associate, gathers voting proxies in relation in **both the Extraordinary Separate Members' Meetings and the Extraordinary General Meetings of FAI Service** to be held exclusively through the use of remote connection systems on 16 December in first call, and, if necessary, **on second call on 17 december 2025** at the **times** specified below:

The form of proxy with the relating voting instructions shall be received, in original, by Monte Titoli by the end of the second day preceding the date set for the Meeting (i.e., by 11:59 p.m. of 12 December 2025 on first call and of 13 December on second call). The proxies and voting instructions may be revoked within the same deadline.

Declaration of the Designated Representative: Monte Titoli declares that it has no personal interest in the proposed resolutions being voted upon. However, taking into account the existing contractual relationships between Monte Titoli and the Company relating, in particular, to technical assistance at the meeting and ancillary services, in order to avoid any subsequent disputes related to the supposed presence of circumstances suitable for determining the existence of a conflict of interest referred to in article 135-decies, paragraph 2, lett. f), of the TUF, Monte Titoli expressly declares that, should circumstances which are unknown at the time of issue of the proxy arise, which cannot be communicated to the delegating party, or in the event of modification or integration of the proposals presented to the Shareholders' Meeting, it does not intend to express a vote different from that indicated in the instructions.
